- a) Presentation of Teacher feedback requested by Community Council in March 2022 meeting (Jay Nolan)
 - i) Mr. Nolan said that 96% of teachers responded to the school
 - (1) Safe at school: 4.19 (of 5) feel safe
 - (2) Respected of school: 3.49 (of 5) feel respected
 - (3) Enjoy teaching at FFJH: 3.82 (of 5) enjoy teaching
 - (4) Feel comfortable interacting with students: 4.34 (of 5)
 - (5) Feel your relationship with students is good: 4.33 (of 5)
 - (6) How much of your day is responding to behavior: 25% (2/3 of teachers)
 - (7) Feel comfortable interacting with parents: 3.32 (of 5)
 - (8) Feel your relationship with parents is good: 3.47 (of 5)
 - (9) Most interactions with parents are positive: 66%
 - (10) Do you feel close to other teachers: 3.32 (of 5)
 - (11) How could the community better support students and teachers? (Comments)
 - (a) Help students understand the value of good work ethic/education
 - (b) Teach respect, responsibility, reasonable expectations
 - (c) Be respectful with your concerns
 - (d) Parents attitude > student attitude
